

"At our luncheon, community leaders, friends, family, and supporters collaborated to deliver on what resulted in a banner year for our annual luncheon. The funds raised will allow VFC to continue fulfilling its core mission of enabling 100 percent GAL representation of children in foster care, while continuing to secure their safety, well-being, stability and quality of life."

The annual fundraising event raises funds to ensure children in foster care have an advocate and a voice in court through Florida's Guardian ad Litem (GAL) program, in addition to providing each child with basic needs, dignity items, and experiences.

Funds raised will help to recruit, train and support Guardians Ad Litem, court-appointed volunteers and staff who serve as advocates for the best interests of foster children in vulnerable situations. Additionally, VFC helps GAL meet children's medical, educational and social needs which include: sourcing dignity items such as clothing, school supplies, bikes, laptops and gifts for their birthdays or the holidays; providing basic necessities such as food assistance, personal hygiene, transportation and housing; and gifting life experiences such as prom, birthday parties, summer camp, college tours and more.
